Program Basics

- ▶ Annual programs funded with taxpayer dollars allocated through the annual County budget cycle
- ▶ \$300,000 available total for both programs
- ▶ Application Cycle Open
- ▶ Application Cycle Closes Monday, April 22, 2024 at 8 am
 - ▶ Late submissions *will not* be accepted
- ▶ We anticipate a competitive grant cycle

Eligible Applicants

- ▶ Not for profit organizations
- ▶ Primarily operating in Johnson county
- ▶ Activities must benefit Johnson County residents broadly

Program Changes

- ▶ Quality of Life Grant Theme
 - ▶ Sustainability and Conservation
 - ▶ Operational Request: to support regular operational expenses for organizations with a mission related to sustainability or conservation
 - ▶ Programming Request: to support expenses for a program focused on the themes of sustainability and conservation

Process Improvements

- ▶ eCivis Portal
 - ▶ Upon award, grantees will be onboarded to the new eCivis portal for more user-friendly contract development, award management, and reporting

How To Apply

- ▶ Review program details and links at johnsoncountyiowa.gov/grants
- ▶ Determine which program you are applying for
 - ▶ Two unique and quite different programs
 - ▶ Ensure your project is a good fit
 - ▶ Likely not worth your time or effort if it is not a good fit
- ▶ Complete an application through Johnson County's Blackbaud Portal
 - ▶ Start an Economic Development application

Application & Portal Walk-Through

Scoring Criteria

- ▶ **Project Design & Innovation**
 - ▶ Does the project have a clear plan, a defined timeline, achievable goals, well-defined activities, clear connection to Board priorities?
- ▶ **Knowledge of Community Need**
 - ▶ Are project activities providing innovative solutions to a well-researched community need and engaging and empowering the residents the project serves?
- ▶ **Impact & Outcomes**
 - ▶ Does the project address short- and long-term impacts and include a variety of methods of impact and project evaluation?
- ▶ **Project Sustainability Plan**
 - ▶ Is there necessary staff expertise and evidence of forward planning to continue the project in the future?
- ▶ **Project Financials**
 - ▶ Is the project budget accurate, cost effective, linked to project activities, and well-explained?

Upcoming Opportunities

- ▶ City Catalyst Grant Program - Currently Under Development
 - ▶ Funding for cities attempting to leverage other funding opportunities
- ▶ Emerging Organizations Grant Program - Currently Under Development
 - ▶ Assistance to small or new nonprofits attempting to gain skills related to and familiarity with grant writing and grant administration
